



3RD BRIDGE PROJECT FINANCING CONTRACT HAS BEEN SIGNED

For the project financing of Yavuz Sultan Selim Bridge that is part of Northern Marmara Highway Project that will be performed by IC İÇTAŞ – Astaldi Consortium and that is considered as an ice breaking bridge, a credit contract of 2.3 billion US Dollars has been signed with the participation of 7 banks.

First signatures are appended for the project financing of Northern Marmara Highway Project that consists of the 3rd Bridge on Istanbul Bosphorus; Yavuz Sultan Selim Bridge, which will be covered by 7 banks. The project financing that will be deferred to 9 years and have an amount of 2.3 billion USD, is the highest project financing credit that is provided at once to a 'greenfield' project in the republic's history. Credit contract has been signed on 29 August 2013 as part of the financing.

The financing request of IC İÇTAŞ – Astaldi Consortium ICA that will realize Yavuz Sultan Selim Bridge and Northern Marmara Highway Project will be covered by the participation of GarantiBank International N.V., T. Garanti Bankası A.Ş., T. Halk Bankası A.Ş., T. İş Bankası A.Ş., T. Vakıflar Bankası T.A.O., T. Ziraat Bankası A.Ş. and Yapı ve Kredi Bankası A.Ş. ICA will undertake the business management of the project, which will be realized with "build, operate, transfer" model for 10 years 2 months 20 days including the investment period.

It will be an ice breaking bridge

Yavuz Sultan Selim Bridge that will be built as part of Northern Marmara Highway Project will be the 3rd bridge to be built on Istanbul Bosphorus after Bosphorus Bridge that entered into operation in 1973 and Fatih Sultan Mehmet Bridge that was completed in 1988.

To be built with advanced engineering and technology by a group consisting mainly of Turkish engineers, 3rd Bosphorus Bridge will be the first bridge to host a 8-lane highway and a 2-lane railway on the same level. It will be the longest and largest suspension bridge of the world with its 59 meters long width and 1408 meters long main span. It will also be the bridge with the longest tower of the world with its height over 320 meters.

Concept design of Yavuz Sultan Selim Bridge is jointly made by "French bridge master" Michel Virlogeux and Swiss T-Engineering company.
